Once your credit application has been processed, you will be notified in writing the amount of credit granted, and your customer number.

If you are a brand new customer, you will be required to pre-pay your first 3 orders.

To maintain your N30 term account, you must purchase a minimum of \$5,000.00 per year and the account must remain in good standing.

Credit Cards used to pay account balances will be assessed a service charge of 2.5%.

PERSONAL GUARANTY

This personal Guaranty is dated _____. It is in favor of tng worldwide, Inc. ("The Secured Party"). The obligations of this Personal Guaranty are joint and several.

The undersigned ("Guarantors") hereby personally guaranty the prompt payment of all obligations identified in the Security Agreement (dated: _____) between the Client ("Debtor") and tng worldwide, Inc. ("The Security Agreement.")

In the event that the Debtor in the Security Agreement fails to make a timely payment of any of its required payment obligations including, but not limited to, any of those identified in the incorporated ("Prior Agreement"), Guarantors shall forward immediate payment (including any accrued interest) to the secured Party at the address identified in the Prior Agreement.

Guarantors understand and agree that notice of a default under the Security Agreement is neither necessary nor required. Guarantor's obligation under this Personal Guaranty is triggered upon the default alone.

Guarantors further understand and agree that the Secured Party under the Security Agreement may pursue its rights under this Personal Guaranty even if it does not pursue its rights against the Debtor under the Security Agreement.

If Guarantors fail to honor any of the obligations set fourth in this Personal Guaranty, the Secured Party shall be entitled to enforce its rights through all means permitted under Michigan law. If enforcement becomes necessary, Guarantors shall pay all of the costs, including attorneys fees, the Secured Party incurs.

To Seller's Customers:
